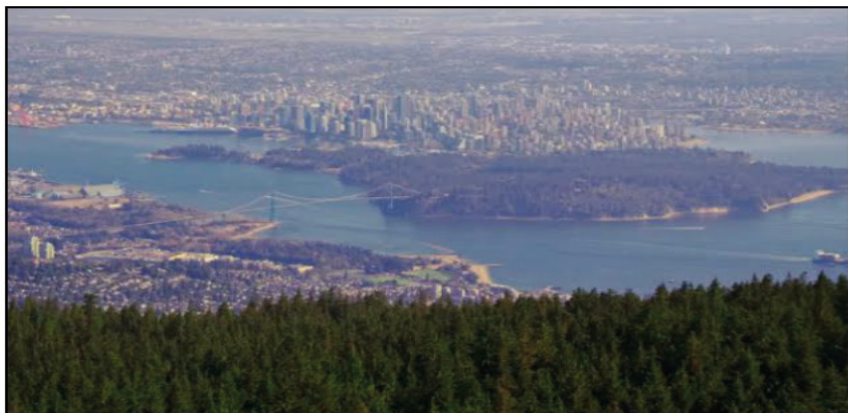

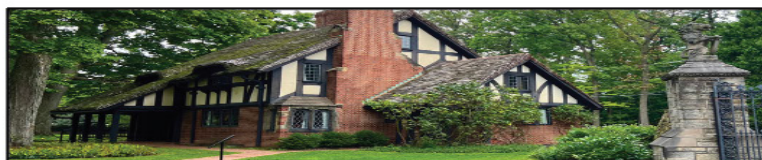

The Twelve Concepts for World Service provide a group of related principles to help ensure that various elements of A.A.'s service structure remain responsive and responsible to those they serve. **Step Five:** "Admitted to God, to ourselves and to another human being the exact nature of our wrongs.." **Tradition Five:** "Each group has but one primary purpose to carry its message to the alcoholic who still suffers." **Concept Five:** "Throughout our world service structure, a traditional Right of Appeal ought to prevail, thus assuring us that minority opinion will be heard and that petitions for the redress of personal grievances will be carefully considered."
